Our Ministry and the Union of Turkish Municipalities (TBB) are organizing together a workshop in Ankara on 7 and 8 of July 2009 about water management at the national, basin and city levels, within the framework of the bilateral cooperation between Turkey and France.

There will be lecturers from both sides, Turkey and France. The programme concerns:

The participants are expected from the provincial directorates, as well as from the Municipalities (above 100000 inhabitants) and their SKIs.

The data on the urban water and sanitation services are to be gathered in a new web data base under the umbrella of the French Ministry in charge of environment.
